## COMMERCIAL CANNABIS BUSINESS ACTIVITY OPPORTUNITY SUMMARY SHEET

Listed below are the type of commercial cannabis business license types permitted within the City and the current number of available licenses. Unless a specific application deadline is identified, applications will be accepted and processed in the order they are received until all available licenses have been allocated.

### COMMERCIAL CANNABIS DISTRIBUTION LICENSE:

The City allows for a maximum of four (4) Commercial Cannabis Distribution Licenses. There are currently two (2) Commercial Cannabis Distribution Licenses available.

### COMMERCIAL CANNABIS LABORATORY TESTING LICENSE:

The City allows for a maximum of four (4) Commercial Cannabis Testing Licenses. All four (4) Commercial Cannabis Testing Licenses are available.

### CITY'S RESERVATION OF RIGHTS

The City reserves the right to reject any and/or all Cannabis Business Permit Application License Type proposal, with or without any cause or reason. The City may modify, postpone, or cancel the request for a specific Cannabis Business Permit Application License Type application without liability, obligation, or commitment to any party, firm, or organization. In addition, the City reserves the right to request and obtain additional information from any candidate submitting a proposal. Late proposals WILL BE REJECTED when a specific deadline has been established. Furthermore, a proposal RISKS BEING REJECTED for the following reasons:

1. It is not responsive to requirements of the Step by Step Guide-Cannabis Business Permit Application, Cannabis Business Application Submittal Checklist and Cannabis Business Permit Application.
2. The issuance of a specific Cannabis Business License type applied for at the proposed location is inconsistent with the state law, LHMC Chapter 18.22 (Commercial Cannabis Activity) or other applicable City of La Habra Municipal Codes.

### AMENDMENTS TO THE APPLICATION

Applicants will not be allowed to make amendments to their application or to supplement their application, except as otherwise specifically permitted in these procedures or as authorized in writing by the Director of Community and Economic Development or his/her designee.
