APPLICATION FOR 2019 OVERNIGHT PARKING PERMIT

New Permit Renewal

Restrictions: Parking permits are not issued to motor-homes, boats, trailers, trucks with campers larger than a shell, commercial vehicles, or vehicles in excess of 6000 lbs. gross weight. No vehicle, including those with parking permits, will be allowed to remain standing (parked) on any street for more than 72 consecutive hours (22651 CVC). Permits shall be considered on a basis of need and not issued solely for convenience. Vehicle must be registered at same address as applicant.

Fee Schedule: Full calendar year- \$34.00. If more than one permit is issued, the charge for each additional vehicle is \$17.00 for the entire period. Replacement of stolen permit is \$7.00
