## Notice to Property Owners

Notice is hereby given that the City of La Habra Planning Commission will hold a public hearing on the following item:

DULY NOTICED PUBLIC HEARING TO CONSIDER REQUESTS FOR DESIGN REVIEW 22-07 FOR A COMPREHENSIVE FAÇADE REMODEL, A BUILDING ADDITION AND VARIOUS SITE IMPROVEMENTS, CONDITIONAL USE PERMIT 22-23 FOR THE OPERATION OF A RESTAURANT (BABY BROS PIZZA & WINGS) AND CONDITIONAL USE PERMIT 22-24 TO ALLOW THE SALE OF BEER AND WINE UNDER A TYPE 41 LICENSE ISSUED BY THE DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL AT 150 WEST WHITTIER BOULEVARD.

This project was reviewed pursuant to the guidelines of the California Environmental Quality Act (CEQA) and determined to be Categorically Exempt pursuant to Section 15303(c), Class 3: "New Construction or Conversion of Small Structures" of the CEQA Guidelines. The project involves façade improvements along with a 320 square-foot addition to an existing commercial building located in an urbanized area for the operation of a restaurant with the sale of beer and wine. The commercial building does not exceed 10,000 square feet in floor area and the site is zoned for commercial uses. The operation of a restaurant does not involve the use of hazardous substances; all necessary public services and facilities are available and the surrounding area is not environmentally sensitive.

The public hearing will be held on Monday, July 10, 2023, at 6:30 p.m. in the City Council Chambers located at 100 East La Habra Boulevard, La Habra, California 90631.

Our records show that you own property within 300 feet of the location of this project. You are invited to attend the hearing and express your views.
