A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA APPROVING THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) SUBSTANTIAL AMENDMENT TO THE ANNUAL ACTION PLAN FOR FISCAL YEARS 2017-2018 AND 2018-2019.

WHEREAS, the City of La Habra conducted a public hearing by the City Council on March 18, 2019, in accordance with the City's adopted Citizen Participation Plan, which was duly public noticed on February 14, 2019; and

WHEREAS, the City of La Habra held a 30-day public review period from February 14, 2019 through March 15, 2019; and


WHEREAS, the City of La Habra is funding one new program during Fiscal Year 2018-2019 as follows;

Program description: The program will consist of constructing a 2,500 square foot splash pad at the park with three showers (required by the Orange County Health Care Agency) for splash pad users to rinse off. Other amenities will include a 50 ft. x 50 ft. shade sail canopy, built in seating benches, 250 ft. tubular steel security fence, decorative security lighting, and three new 24' box trees.


